## VANCE WHITE RESIGNS

Vance White, the SOA General Manager hired in the summer of 2005, has resigned. The board voted unanimously to promote Sonny Stutts as the permanent GM. The board also changed the organizational structure and hired a new manager of the Summit Enterprises, Inc. (SEI). Dee Dee Beavers, the new SEI Manager, will oversee the rental operations, laundry, gift shop, and Tiki Bar. She will begin work at the first of the year.

## BOARD CHANGES

Kent Whiddon resigned from the BOD and was replaced by Richard Bourgoise. Bourgoise is from Michigan and owns Unit 1206.

## ASSESSMENT AND FEES INCREASE

The BOD voted for a special assessment to cover the budget shortfall of 2008. The quarterly fees have also increased and will include funding up front for a special coating for the walkways planned for 2011. Hopefully, 2009 will see increases in revenues but, with the economic conditions, there are no assurances.

## PROPERTY IMPROVEMENTS

A medium blue tile will be added to the west end pool as soon as final approval is received from the state. The state mandated the removal of the black tile. The east pool will eventually be changed as well. The Wi-Fi has been improved and reception is much better. All of the north side of the building has been painted except the towers. The towers will be painted soon and will have some accent color to give the building a more modern look. Improvements are planned for the shuffleboard court.

## BY-LAWS

From the oops department, I inadvertently left out the results of the proposed by-law change that was voted on at the September meeting. The vote was 154 'yes' to 49 'no', failing to gain the required 2/3 vote to change. It is extremely difficult to get a 2/3 vote at The Summit. Without a 2/3 vote, the staggered terms of board members will end because of a change in Florida law. This means every board member could be replaced all at once leaving no continuity. You may be asked in the future to vote to keep the staggered terms by making a change to the bylaws.
